- first line hormone treatment of hormone-dependent metastatic breast cancer in postmenopause

Varicella zoster virus infections:

- treatment of first and recurrent episodes of genital herpes in immunocompetent adult patients
- treatment of recurrent episodes of genital herpes in immunocompromised adult patients
- suppression of recurrent genital herpes in immunocompetent adult patients and immunocompromised adult patients

- decompensated liver disease

For both compensated and decompensated liver disease, this indication is based on clinical trial data in nucleoside naive patients with HBeAg positive and HBeAg negative HBV infection with respect to patients with lamivudine-refractory hepatitis B

- CMV prophylaxis with Valavex in subjects receiving solid organ transplantation (kidney) reduces the occurrence of acute graft rejection, opportunistic infections and other herpes virus infections (HSV, VZV)
